



## IFSC Connected Speed Knockout 2020 Rules

### 0. Introduction

We welcome Member Federations that accepted to attend the 2020 IFSC Connected Speed Knockout. We require your collaboration in order to make this competition exciting.

The intent of these rules is to create fair conditions for everybody. At the same time, if there are any inconsistencies or missing points, IFSC Rules apply.

### 1. Quota and generic rules

Each Member Federation could register a maximum of 5 competitors per gender. Practice is possible before the start of the competition. When the judge declares the start of the competition, cameras are switched on and competition is recorded. The clock should be filmed at the end of each race. Team Members shall wear their team uniform as per IFSC Rules.

### 2. Competition procedure - Qualifications

The Qualifications will be conducted as for IFSC Rules. Women start first, so that we can ensure consistency with all participating Member Federations. Each climber runs two lanes (A and B). Starting order is decided autonomously by participating Member Federations. Athletes shall compete in pairs, alternate by gender. Example below.

WOMEN	Lane A	Lane B
Race 1	Athlete W1	Athlete W2
Race 2	Athlete M1	Athlete M2
Race 3	Athlete W3	Athlete W4
Race 4	Athlete M3	Athlete M4
Race 5	...	...

As for IFSC Rules, athletes who committed False Start are out of the competition. The opponent athlete should re-run. 5 minutes break will be observed before the start of Finals.

### 3. Competition procedure – Finals

Each climber will be required to run 4 races in lane A. The races will represent the following rounds:

- 1/8 of finals
- Quarter Finals
- Semi-finals
- Finals

All races will be recorded. The IFSC will generate the pairs and start list for Finals in post-production. The IFSC will publish the complete video of the event with the ranking of the competition. The ranking will follow IFSC rules and each climber will be virtually compared against the opponent for the duration of all finals.

The rounds will be recorded in the following order:

- 1/8 Finals Women

- 1/8 Finals Men
  - 1/4 Finals Women
  - 1/4 Finals Men

Within each round, starting order should be the same as Qualifications.

#### 4. General procedures

The appointed judge is responsible to monitor the fair running of the competition, according to the present document. The video should be ON during all the duration of competition. It is not possible to produce more than one video and to select the one to send to IFSC. The appointed judge shall also send to the IFSC office an excel with the summary of all the results and race times.

IMPORTANT: Please note that it is not possible to share any videos and information about the event. The IFSC is the only body that shall receive all the elements.
